Patient Organisation Support Agreement

Re: Financial support

Dear Svend Aage Madsen

Thank you for your request to Astellas Pharma to provide support to Selskab for Mænds Sundhed.

This letter agreement describes the terms and conditions with which you and Astellas agree to comply regarding the sponsorship.

Financial support and conditions

We are pleased to inform you that we will be able to offer a grant of **DKK 30.000** for a non-financial support for "Rundbordssamtale - Forum for mænds sundhed" at Tivoli Hotel and Congress Center. It is estimated that the collaboration will be completed no later than 30.01.2014.

Delivery of support

The organisation will receive the financial support no later than 30 days after submission of data through our web based application (Astellas FAS).

Your login details to Astellas FAS will be e-mailed to you.

In Astellas FAS you must select the option to claim the financial support by enclosing an invoice.

Financial support can only be paid to an official account of the relevant organisation and not to an individual.

You agree that you will be solely responsible for the payment of all taxes and any other charges or deductions related to the Support.

Representations and obligations

The Parties declare in signing this Agreement that the Organisation shall be free to collaborate with several pharmaceutical companies and that the Company shall be free to collaborate with one or more organisations.

The Parties further state that their relations shall not involve exclusive rights with respect to specific product or therapeutic areas. The Company agrees in signing this Agreement not to impose conditions for the Organisation's professional or stakeholder-policy viewpoints

The Company agrees in signing this Agreement that it has no executive duties in the Organisation that have any significance for the present Agreement.

Both Parties confirm that the sum awarded does not exceed the true costs of the activity and that the scope of the Support is clear. You agree that the scope of the Support to be provided is clear and you accept that nothing relating to this agreement is to be taken as implying that the Company expects you to recommend or promote the prescription, administration or sale of any product of the Company and you confirm that it is your understanding that the Support does not constitute an illegal inducement.

Transparency

In the interests of transparency, Astellas will list your organisation on our website www.astellas.dk as having received support from us. We will also report the grant to the code of practice authority as required by local regulations. We encourage you to acknowledge the support you have received from Astellas on outputs or events from the project and in any public documents or websites you produce.

Outputs and regulations

Pharmaceutical industry codes of practice and national regulations have strict requirements relating to communications on medicines including that we should not promote our products to the public directly or indirectly. Since we may be held responsible for outputs that we have sponsored can you please send me draft copies of any such outputs for our review and internal approval. This is not intended to compromise your independence but simply to ensure that Astellas complies with applicable regulations.

Data Protection

The Parties shall comply with all data protection and privacy laws and regulations, including without limitation, the Data Protection Act 1998, the Privacy and Electronic Communications (EC Directive) Regulations 2003 and all other applicable legislation, regulations and guidance implemented pursuant to EC Directives 95/46/EC and 2002/58/EC. In the course of this agreement and the provision of Support, the Company may be provided with personal data and you consent to such personal data being shared with the Company and its affiliated companies.

Breach of Agreement

If one of the Parties is in breach of its obligations under this Agreement, the other party may terminate the Agreement with immediate effect and the latter party shall be entitled to seek other legal redress in Danish law for breach of agreement, including a claim for compensation irrespective of whether the Agreement shall have been terminated.

Law

This Agreement shall be subject in every respect to Danish law.
